

7.1.5: Green campus Policy

1. Purpose

The University is dedicated to promoting environmental sustainability by encouraging eco-friendly actions and minimizing plastic waste. This policy highlights our commitment to cultivating a green campus and phasing out single-use plastics.

2. Scope




